**FINDINGS OF FACT, CONCLUSIONS OF  
LAW AND ORDER**

This cause came on the regularly scheduled hearing before the Board of Oil, Gas and Mining ("Board"), on Wednesday, May 27, 2009, at 9:00 a.m., held at the Utah State Capital Complex-East Building.

The following Board members were present and participating in the hearing: Chairman Douglas E. Johnson, Ruland J. Gill, Jr., Jake Y. Harouny, James T. Jensen, Kelly L. Payne, and Jean Semborski. Michael Johnson, Esq., Assistant Attorney General, represented the Board. Attending and testifying on behalf of the Division of Oil, Gas and Mining ("**Division**") was Dustin Doucet, Petroleum Engineer. Steve Alder, Esq., Assistant Attorney General, represented the Division. The Division's position was in support of the Request.

Testifying on behalf of Harvest (US) Holdings, Inc. ("**Petitioner**") were Gil Porter, CPL, Manager of Land for Petitioner, Eugene Williams, of Williams Petroleum Consulting, consulting

petroleum engineer and Martin Shields, Phd, of Branta Exploration and Production, LLC, geoscientist. Chris D. Jones, Esq. of Holland & Hart LLP represented the Petitioner.

Johnna Blackhair appeared for the Bureau of Indian Affairs and voiced support for the Petitioner's Request for Agency Action (as twice amended, the "**Request**"). In advance of the hearing, Jerry Kenczka, Assistant Field Manager for Land and Minerals for the United States of America, Bureau of Land Management had previously submitted to the Board a letter in support of the Request, dated April 8, 2009.

No other statements were made at the hearing in opposition to the Request and no other parties participated in the hearing.

NOW THEREFORE, the Board, having fully considered the testimony and exhibits presented at the hearing, and being fully advised in the premises, and for good cause appearing, by unanimous vote, hereby makes and enters its Findings of Fact, Conclusions of Law, and Order, as follows:

#### **FINDINGS OF FACT**

1. Notices of the time, place and purpose of the May 27, 2009 hearing were mailed to all interested parties, and were duly published in the Salt Lake Tribune, Deseret News, and the Uintah Basin Standard pursuant to the requirements of Utah Administrative Code ("U.A.C.") Rule R641-106-100.

2. Pursuant to U.A.C. R641-104-135, Petitioner mailed photocopies of the Request for Agency action on February 10, 2009, to the last known addresses of all Owners (as defined in Utah Code Annotated § 40-6-2) having interests in the area to be spaced, by certified mail, return receipt requested.

3. Petitioner is a Delaware corporation in good standing and authorized to conduct business in the State of Utah.

4. Petitioner owns or controls working interests in the following lands that are the subject of the Request and are sought to be spaced (“**Subject Lands**”):

T3S, R2W, USM, Duchesne County, Utah

Section 20: All

Section 29: All

5. The Subject Lands are Ute Indian allottee lands and private (fee) lands.

6. The Subject Lands are currently not subject to any spacing orders and are governed by the general well-location and siting rules set forth in the Utah Administrative Code R649-3-2(1), authorizing a well to be drilled for production in the center of a 40 acre public land survey quarter-quarter section or equivalent lot with a tolerance of 200 feet in any direction from the center location.

7. No wells have been drilled on or are currently producing from the Subject Lands.

8. The Subject Lands are underlain by the Mesaverde Formation.

9. The interval sought to be spaced is the Mesaverde Formation, an identifiable stratigraphic horizon throughout the Uinta Basin, and for purposes of identification, the Mesaverde Formation shall be that interval in the Coors Energy (Gulf-Linmar) Ute Tribal 1-27D3 Well, located in the NW/4SW/4 of Section 27, T4S-R3W, USM beginning at a measured depth of 11,560 feet down to a measured depth of 15,790 feet (“Spaced Interval”).

10. Initial spacing patterns for the Spaced Interval in the Subject Lands should comprise 640-acre drilling units conforming to the public land survey sections.

11. Wells drilled on the Subject Lands to produce from the Spaced Interval should be located so that the bottom hole location is within one of the four internal quarter-quarter sections

of each section, as described on the testimony and exhibits for Section 29 and for Section 20, or as determined during the administrative processing of Applications for Permit to Drill.

12. An area of 640 acres is no smaller than the maximum governmentally surveyed area that can be efficiently and economically drained by one well producing from the Spaced Interval in the Subject Lands.

13. Only one well producing from the Subject Interval should be permitted for each 640-acre drilling unit.

14. The establishment of 640-acre drilling and spacing units in the Subject Lands conforming to public land survey sections or equivalent lands will allow for the orderly development, prevent waste by drilling unnecessary wells, protect correlative rights of the effected parties, promote the public interest, increase ultimate recovery and is just and reasonable under the circumstances.

#### **CONCLUSIONS OF LAW**

15. The Board has jurisdiction of the parties and of the subject matter of the Request, as amended, pursuant to Chapter 6 of Title 40 of the *Utah Code Annotated*.

16. Due and regular notice of the time, place and purpose of the hearing was properly given to all interested parties as required by law and by the rules and regulations of the Board and Division.

17. Petitioner properly served all owners entitled to notice at the last known address by mailing copies of the Request to those owners having legally protected interests.

18. A 640-acre drilling unit is not smaller than the maximum area within the Subject Lands that can be efficiently and economically drained by one production well from the Spaced Interval. 640-acre drilling units are of a uniform size and shape across the Subject Lands.

19. The reasons for seeking a spacing order and the terms and conditions sought by the Request are just and reasonable.

20. An order establishing drilling units on 640-acre patterns for the production of oil, gas and associated hydrocarbons from the Spaced Interval in the Subject Lands will promote the public interest, increase ultimate recovery, prevent waste, and protect correlative rights.

### **ORDER**

Based upon the Request, the testimony and evidence submitted by the Petitioner and the Division, and the Findings of Fact and Conclusions of Law stated above, the Board hereby orders:

21. The Request for 640-acre drilling and spacing units for the Subject Lands for the production of oil, gas and associated hydrocarbons from the Spaced Interval is hereby granted.

22. Drilling units shall comprise 640-acre public land survey sections or equivalents, for the Subject Lands and Spaced Interval.

23. The bottom-hole location of permitted well within each drilling unit shall be centrally located within one of the internal quarter-quarter sections of such section (i.e., SW/4NE/4, SE/4NW/4, NE/4SW/4, or NW/4SE/4), as shown on the exhibits presented or as determined during the administrative processing of Applications for Permit to Drill.

24. Administrative approval may be granted for exception well locations for topographic, environmental and archeological considerations, without the necessity of a full hearing before the Board.

25. Petitioner shall, within eighteen (18) months of the date of this Order submit a report to the Division regarding the results of drilling and all relevant and available data pertaining to what spacing is appropriate for the Subject Lands. Petitioner shall meet with the

staff of the Division to review such information and to determine if additional production and engineering data are needed, if any, and the timetable for obtaining the additional data. The Division shall, within twenty (20) months of the date of this Order, report to the Board concerning its review of the data submitted by Petitioner and the continued appropriateness of 640-acre spacing on the Subject Lands. In the event the drilling results indicate that additional information is required, or that a different well spacing may be justified, then Petitioner, the Division, or the Board on its own motion, may seek a modification of the Order to allow time to obtain and evaluate additional information or to modify the Order to conform with the newly determined evidence.

26. The Board has considered and decided this matter as a formal adjudication, pursuant to the Utah Administrative Procedures Act, Utah Code Ann. §§ 63G-4-204 through 208, and of the Rules of Practice and Procedure before the Board of Oil, Gas and Mining, Utah Admin. Code R641.

27. This Findings of Fact, Conclusions of Law, and Order (“**Order**”) is based exclusively upon evidence of record in this proceeding or on facts officially noted, and constitutes the signed written order stating the Board’s decision and the reasons for the decision, as required by the Utah Administrative Procedures Act, Utah Code Ann. § 63G-4-208, and the Rules of Practice and Procedure before the Board of Oil, Gas and Mining, Utah Admin. Code R641–109; and constitutes a final agency action as defined in the Utah Administrative Procedures Act and Board rules.

28. **Notice of Right of Judicial Review by the Supreme Court of the State of Utah.** As required by Utah Code Ann. § 63-G-4-208(e) through (g), the Board hereby notifies all parties to this proceeding that they have the right to seek judicial review of this Order by

filing an appeal with the Supreme Court of the State of Utah within 30 days after the date this Order is entered. Utah Code Ann. § 63G-4-401(3)(a) and 403.

29. **Notice of Right to Petition for Reconsideration.** As an alternative, but not as a prerequisite to judicial review, the Board hereby notifies all parties to this proceeding that they may apply for reconsideration of this Order. Utah Code Ann. § 63G-4-302. The Utah Administrative Procedures Act provides:

(1) (a) Within 20 days after the date that an order is issued for which review by the agency or by a superior agency under Section 63-46b-12 is unavailable, and if the order would otherwise constitute final agency action, any party may file a written request for reconsideration with the agency, stating the specific grounds upon which relief is requested.

(b) Unless otherwise provided by statute, the filing of the request is not a prerequisite for seeking judicial review of the order.

(2) The request for reconsideration shall be filed with the agency and one copy shall be sent by mail to each party by the person making the request.

(3)(a) The agency head, or a person designated for that purpose, shall issue a written order granting the request or denying the request.

(b) If the agency head or the person designated for that purpose does not issue an order within 20 days after the filing of the request, the request for reconsideration shall be considered to be denied.

*Id.*

The Rules of Practice and Procedure before the Board of Oil, Gas and Mining entitled “Rehearing and Modification of Existing Orders” state:

Any person affected by a final order or decision of the Board may file a petition for rehearing. Unless otherwise provided, a petition for rehearing must be filed no later than the 10th day of the month following the date of signing of the final order or decision for which the rehearing is sought. A copy of such petition will be served on each other party to the proceeding no later than the 15th day of that month.

Utah Admin. Code R641-110-100.

The Board hereby rules that should there be any conflict between the deadlines provided in the Utah Administrative Procedures Act and the Rules of Practice and Procedure before the Board of Oil, Gas and Mining, the later of the two deadlines shall be available to any party moving to rehear this matter. If the Board later denies a timely petition for rehearing, the aggrieved party may seek judicial review of the order by perfecting an appeal with the Utah Supreme Court within 30 days thereafter.

30. The Board retains exclusive and continuing jurisdiction of all matters covered by this Order and of all parties affected thereby; and specifically, the Board retains and reserves exclusive and continuing jurisdiction to make further orders as appropriate and authorized by statute and applicable regulations.

31. The Chairman's signature on a facsimile copy of this Order shall be deemed the equivalent of a signed original for all purposes.
