NOW, THEREFORE, the Board, being fully advised in the premises, finds as follows:

1. Due and regular notice of the time, place and purpose of the hearing was given to all interested parties in the form and manner and within the time required by law and the rules and regulations of the Board.

2. That the "Order to Show Cause" was issued because it was thought that all of Section 30, Township 8 South, Range 22 East, SLBM, was committed to the Glen Bench Unit Agreement.

3. That subsequently it was determined that certain leases owned by Conoco Oil Company in the South half of Section 30, as well as some unleased acreage, had not been committed to said unit agreement.

4. That Conoco and the individuals owning the unleased acreage requested that the south half of Section 30 remain a 320 acre drilling unit as established by the order issued in Cause No. 173-1.

5. That there will be no violation of correlative rights by the granting of said request.






